AMENDMENTS ON THE BALLOT

Amendment 1 - *Vote Yes*

Authorizes the state legislature to pass laws prohibiting flood resistance improvements made to a home from being taken into consideration when determining a property's assessed value for property tax purposes

Amendment 2 - *Vote Yes*

Abolishes the Florida Constitution Revision Commission

Amendment 3 - *Vote Yes/No (up to each voter)*

Authorize the Florida State Legislature to provide an additional homestead property tax exemption on \$50,000 of assessed value on property owned by certain public service workers including teachers, law enforcement officers, emergency medical personnel, active duty members of the military and Florida National Guard, and child welfare service employees
